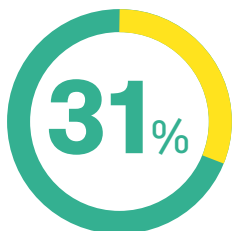

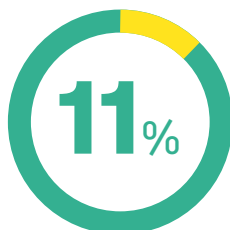

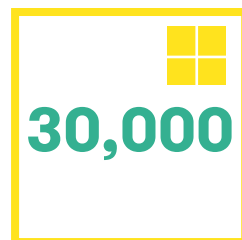

Improving the quality of homes for the future

More than 4.3m homes in England do not meet the **Decent Homes Standard**, including nearly a quarter of private rented homes.

How investment in social housing can make the difference

We need homes where we can be happy, homes where children can thrive, homes where we have communities around us, and homes that help us to live independently and well.

Investing in social housing makes this possible. Social housing is one of the country's greatest assets. Investment in social housing and support for the people who live in it is good for the economy, creating jobs and improving wellbeing. It must be at the heart of the nation's recovery.



51,000

In 2018-19, housing associations and local authorities in England built almost **51,000** affordable homes – more than a quarter of all new homes.

£2.7bn

This added an estimated **£2.7bn** to the national economy, supporting more than **48,500 jobs**.
